The Tax Rates are applied to each 100 Dollars of Value (Example)

1. ADD Applicable Tax Rates Together = Total Tax Rate..... .5650 + .095 = .6600 (General County + Valley Hill Fire)
2. Total Tax Rate DIVIDED BY 100 = Adjusted Rate..... .6600 / 100 = .006600
3. Adjusted Rate TIMES Tax Value = Tax Bill..... .006600 x \$100,000 = \$660.00
