INSTRUCTIONS TO PROPOSERS

1. **IN GENERAL:** In order for a proposal to be considered, it must be based on terms, conditions and Scope of Services contained herein and must be a complete response to this RFP. One (1) original and one (1) copy of each Proposal shall be submitted. The copy must consist of all documents that are included in the “Original” Proposal. No other distribution of the Proposal shall be made by the Proposer. Proposals must be signed by an authorized representative. Each Proposal must be either stapled or bound in a single volume with all relevant documentation. Each Proposal should be ordered as follows:

- Cover sheet (page 2 of this RFP)
- Pricing proposal sheet
- Addendum Acknowledgement Form
- Iran Divestment Certification

2. **PRE-PROPOSAL CONFERENCE AND COMMUNICATIONS WITH PROPOSERS:** **No** pre-proposal conference will be scheduled. All recipients of this request for proposals who are considering response **must** register by email, at rfp-response@hendersoncountync.org. No interpretation of the meaning of the specifications or other proposal documents will be made to any proposer orally.

All questions submitted and any response thereto will be sent by email to all entities registered as an emailed addendum to this request for proposals. **All questions must be received at rfp-response@hendersoncountync.org by not later than noon on June 30, 2017, without exception.**

3. **PROPOSAL DUE DATE:** Proposals will be received until noon on July 10, 2017. Proposals must be in writing, and must be mailed or hand delivered to:

4. **LATE PROPOSALS:** Proposals received after the date and time specified will not be considered for award and will be returned to the Proposer unopened.

5. **OPENING OF PROPOSALS:** Proposals will be opened shortly after noon on July 10, 2017, in Room 120 (Burrell office) of the Historic Courthouse, located at 1 Historic Courthouse Square, in Hendersonville, North Carolina.

6. **EXEMPLAR NOTICES AND THEIR USE:** This Request for Proposals includes examples of a notice of the type to be included in the proposal. Included with each of the examples is a “word count” taken from the Microsoft Word file. Calculation of bids is to be based in part on the use of

these examples, as stated in the Evaluation and Award Criteria. **The exemplar files may be obtained by downloading the Microsoft Word files from a sharefile account, the address of which will be provided to those who have registered at rfp-response@hendersoncountync.org.** The address will be provided within one (1) day of registration at rfp-response@hendersoncountync.org.

7. DISCREPANCIES AND OMISSIONS: Should discrepancies be located in, or omissions be identified from the documents, or should be in doubt as to their meaning, the Proposer should at once notify the County, and an emailed addendum will be issued. The County will not be responsible for any oral instructions. Acknowledgment of an addendum received shall be noted on the Proposal in the attachment provided. In closing of a contract, any Addendum issued shall become a part thereof.

8. REQUIREMENT OF PROPOSER TO MEET STATUTORY REQUIREMENTS: A proposal **must** affirm (using the same form provided, or one substantially identical):

- That the proposed publication meets all statutory requirements in North Carolina for legal advertisement by a county government, including particularly those contained in Article 50 of Chapter 1 the North Carolina General Statutes, and in Chapters 105 and 153A of the North Carolina General Statutes.
- That the Proposer is not listed on the North Carolina State Treasurer's Iran Divestment list.
- That the Proposer, and any subcontractor, complies with the requirements of E-Verify in North Carolina.

9. TERM OF CONTRACT: The initial term of the contract is from Date of Award through June 30th, 2018. This contract may be terminated, in whole or in part, at the sole option of the County if the County is no longer required, under North Carolina law, to used newspaper publication.

10. RESERVATION OF RIGHTS: The County reserves the right to select the proposal which best meets the needs of the County. The successful proposer will enter into a contract with the County incorporating all prescribed requirements and conditions of this request for proposal. If the successful proposer refuses or fails to execute the contract, the County may consider the next most qualified proposer. The County shall be the sole judge as to the successful proposer. The County reserves the right to reject any or all responses to this Request for Proposals and to waive any informality or irregularity in this Request or in responses, to negotiate with all qualified sources, or to cancel, in part or in its entirety, this Request, in the best interest of the County. This Request for Proposals does not commit the County to award a contract or to procure or contract for services.

11. BILLING UNDER CONTRACT: Publication costs under this agreement will be billed to the County at the **lowest** of the "per word" or "per half page" basis cited in the successful proposal for the particular advertisement.

SCOPE OF SERVICES

The scope of services desired includes print advertising for County legal notices, classified employment advertisements, and general purpose display advertisements. The scope for all services includes, at a minimum:

1. Proposer shall have the capability to receive materials and proofs via email. Proposer shall provide City with an email address to be used for transmission of such matter.
2. County departments will submit a draft of the publication, in Microsoft Word format, together with a statement of how often (both frequency and duration) the publication is to be made. At the option of the county department submitting the draft, the Proposer may be required to respond to the submitting department the cost of such publication in advance of publication.
3. The Proposer will provide deadlines for publication in its newspaper, which deadlines shall be not greater than four (4) business days prior to the date of first publication.
4. The Proposer shall submit proof of publication in a form meeting the requirements of applicable North Carolina law, including but not limited to section 1-597 of the General Statutes.
5. Invoicing shall be on a monthly basis, separated by requesting county department for advertisements (or as otherwise specified on the advertisement submission).
6. The Proposer should be aware that on occasion, emergency situations may require special handling to meet specific dates. The Proposer must agree and be prepared to assist the County in these special situations.
7. The contract that may be awarded shall be valid from the date of approval through June 30, 2017.
8. The ability to publish duplicate advertisements on a publicly-available website will be considered a plus in the evaluation of the bid.

SUBMITTAL, EVALUATION AND AWARD CRITERIA

CONTENTS OF SUBMITTAL: Each submittal will contain the following:

- A. An executive summary, clearly articulating the ability to meet each of the requirements of this Request.
- B. Four (4) notices as they would be published, using the four (4) exemplar notices supplied with this Request for Proposals.
- C. Cost calculations, consisting of:
 - (1) A statement of the total cost of publication, on a one time per week basis, for one week, for each of the four (4) exemplar notices provided; and,
 - (2) A statement of the cost, **per word** (using the Microsoft Office word count, provided), for the publication of each of the four (4) exemplar notices on a one time per week basis, for one week, and if the cost per word differs between the examples, the basis for the difference, and the method for its calculation.
 - (3) A statement of whether the cost, per word, would differ significantly if, in the case of Example 4, the word count was approximately ten (10) times larger (in other words, if the example was the full 2016 published late tax notice).
 - (4) A cost calculation, per full half-page of text (with “page” defined as 11” x 17”, with the margins for page and columns identical to the text pages in the proposer’s newspaper, and using a typeface no larger than eighty percent (80%) of that used for news stories in the proposer’s newspaper).
- D. A statement of whether advertisements will be duplicated on a publicly-available website.

Criteria:

The cost per word will count a maximum of 85 points, with proposal indicating the lowest cost per word being awarded 85 points, the next lowest proposal being awarded 80 points, the next lowest proposal being awarded 75 points, and so on.

The cost per half-page will count a maximum of 15 points, with the proposal indicating the lowest cost per word being awarded 15 points, the next lowest proposal being awarded 10 points, the next lowest proposal being awarded 5 points, and so on.

Points awarded will be combined as the newspaper’s score.

**NOTICE OF PUBLIC HEARING
ON PROPOSED ZONING MAP AMENDMENT
(Rezoning Requests #R-2044-05 (A,B,C))**

The Henderson County Board of Commissioners will hold a public hearing for the proposed map amendments to the Official Zoning Map of Henderson County, North Carolina.

The proposed zoning map amendments are the product of the small area plans in Gerton (adopted May 11, 2030), Uno (adopted March 16, 2041), and Bowman’s Bluff (adopted February 19, 2044). These rezonings were reviewed and recommended by the Henderson County Planning Board at its October 16th meeting.

The Henderson County Board of Commissioners will hold a public hearing on the proposed zoning map amendments that would rezone approximately 28,427.7 acres within Henderson County. The Gerton Community Plan Land Use Recommendations propose a total of approximately 1,137.5 acres to be rezoned. The following list indicates the approximate acreage of each zoning change within the Gerton Community Plan: 495.2 acres to Local Commercial (LC), 52.8 acres to Office and Institutional (OI), 537.8 acres to Residential One (R1), and 51.8 acres to Community Commercial (CC). The Uno Community Plan Land Use Recommendations propose a total of approximately 310.3 acres to be rezoned. 222.7 acres to Residential One (R1) and 87.6 acres to Industrial (I) represent proposed zoning map amendments for the Uno Community Plan. The Bowman’s Bluff Community Plan Land Use Recommendations propose a total of approximately 26,966.1 acres to be rezoned. The following list indicates the approximate acreage of each zoning change within the Bowman’s Bluff Community Plan: 3,409.9 acres to Residential Four (R4), 207.0 acres to Local Commercial (LC), 23,322.8 acres to Residential Two Rural (R2R), and 40.1 acres to Residential Two (R2). The proposed zoning map amendments can be viewed on the Henderson County Planning Department at www.hcplanning.org to see the affected parcels. Additionally, Planning Department Staff will have printed maps available for view in the Planning Department (See Address Below).

The public hearing will be held on Wednesday, November 19, 2044, at 9:00 A.M., in the Board of Commissioners Meeting Room located in the Henderson County Historic Courthouse, at 1 Historic Courthouse Square, in Hendersonville, NC. The public is invited to attend and comment on the proposed amendment.

Written comments addressed to the Henderson County Board of Commissioners, 1 Historic Courthouse Square, Suite 1, Hendersonville, NC 28792, will be accepted prior to the hearing. Information about the proposed amendment is available for review in the Henderson County Planning Department, 100 N. King Street, Hendersonville, NC, between the hours of 8:00 A.M. and 4:30 P.M., Monday through Friday, or on the Henderson County Website at www.hcplanning.org. For more information, call the Planning Department at (828) 697-4819.

Please note that after considering public hearing comments, the Board of Commissioners may discuss other options or make changes to the proposed amendments before taking final action. The

Henderson County 2020 Comprehensive Plan will be updated and amended, as necessary, to reflect the action of the Board of Commissioners.

NOTICE IS HEREBY GIVEN pursuant to N.C. Gen. Stat. §158-7.1 that the Henderson County Board of Commissioners will hold a public hearing at a special meeting on December 12, 2011, at 5:30 p.m., or as soon thereafter as the Board can consider the matter, to consider the request of a company (“Project 300 Company”) for economic development incentives. The date and time of this special meeting is subject to change by the Board of Commissioners at its December 5, 2011, meeting.

Project 300 Company is a manufacturing concern located outside Henderson County contemplating locating an additional facility in Henderson County.

Under the project as proposed, the public benefit to be derived from the capital project is a total taxable capital investment by Project 300 Company of at least \$45,000,000.00 in real estate acquisition and improvement, and at least \$70,000,000.00 in business personal property (equipment). The project would result in the creation of not fewer than one hundred twenty-five (125) new jobs, at an average wage in excess of the County’s average manufacturing wage for full-time employment, plus other benefits. The contemplated incentives would be to assist the Company with some or all of land acquisition, site development and preparation, water, sewerage, and construction. The incentives, in a total maximum amount of \$3,750,000.00, would be accounted for over a period of seven years, based on the size and scope of the new investment, the number of new employees, and the Board’s incentives guidelines.

Henderson County will consider granting assistance toward actual start-up expenditures incurred in Project 300 Company’s investment.

If approved, the request would be funded through the general property tax revenue. The hearing will be held in the Commissioners Meeting Room of the Historic Courthouse, located at 1 Historic Courthouse Plaza, Hendersonville, NC. The public is invited to attend and comment.

ADVERTISEMENT OF TAX LIENS ON REAL PROPERTY FOR THE TAX YEAR 2015

Under and by virtue of the authority vested in the position of Tax Collector by Section 105-369 of the North Carolina General Statutes, and pursuant to an Order by the Henderson County Board of Commissioners, the Henderson County Tax Collector is hereby advertising tax liens on all unpaid 2015 bills for real property as of 5:00 p.m. on 29 February 2016.

North Carolina General Statute 105-369 requires tax liens be advertised in the name of the owner as of the date of delinquency. The date of delinquency for 2015 taxes was 6 January 2016. The Office of the Henderson County Collector recently mailed second notices to owners listed in this advertisement in an effort to promote payment of the taxes and prevent advertisement.

If these taxes as advertised remain unpaid, the Office of the Henderson County Collector may foreclose on the tax lien and sell the real property to satisfy all claims of unpaid taxes. In accordance with the North Carolina law, the Office of the Henderson County Collector uses enforced collection methods, such as bank attachment, wage garnishment or rent attachment, along with foreclosure. Should the use of any of these methods be necessary, any additional costs will be added to the amount of tax currently due.

While we do not wish to embarrass property owners by publishing their names in the newspaper, the advertisement of property tax liens is a very serious matter as it signifies the beginning of the foreclosure process.

North Carolina General Statute 105-348 states:

“All persons who have or who may acquire any interest in any real or personal property that may be or may become subject to a lien for taxes are hereby charged with notice that such property is or should be listed for taxation, that taxes are or may become a lien thereon, and that if taxes are not paid the proceedings allowed by law may be taken against such property. This notice shall be conclusively presumed, whether or not such persons have actual notice.”

Based on the above statutory language, it is the responsibility of the property owner, not the governing body, to determine if he/she owes taxes and to see that those taxes are paid. If you are currently in bankruptcy proceedings, please notify our office so we may adjust our records accordingly.
